Official Rules for Western Canada

1. Introduction

This 2026 Envu Greenhouse Grower – Contest (the “**Contest**”) is sponsored by 2022 Environmental Science CA Inc. (“**Envu**”). This document constitutes the official rules of the Contest (the “**Rules**”) and the Rules exclusively govern all aspects of the Contest. Entry of a participant in this Contest constitutes that participant’s irrevocable acceptance of and agreement to be bound by all Rules of the Contest.

Timing of Contest

The Contest begins on Monday January 19th 2026 at 9:00am EST and ends on Friday March 27 at 5:00pm EST (the “**Contest Period**”). Envu reserves the sole and unfettered right to change the Contest Period. Participants are, by these Rules, advised any such change(s) could materially affect the chances of winning.

2. Eligibility to Enter

The Contest is open only to Greenhouse Growers in Western Canada who meet all of the following criteria:

- a. owners and employees of greenhouse producers in British Columbia, Alberta, Saskatchewan and Manitoba;
- b. have been invited by Envu or one of its distributors to participate in the Contest during the Contest Period;
- c. are of legal age or older;
- d. are legal residents of Canada; and
- e. meet all other requirements set out in the Rules.

(“**Eligible Participants**” or each an “**Eligible Participant**”).

Employees of Envu and members of their respective households (individuals with whom they reside in the normal and customary course of their residency) are not eligible to enter the Contest.

3. How to Enter

No purchase of Envu products is necessary to enter the Contest. A purchase of Envu products will not increase an Eligible Participant’s chance of winning. Chances of winning cannot be determined by Envu prior to the end of the Contest Period and will be dependent on the number of Eligible Participants participating in the Contest and the number of Entries (as defined below) received.

Eligible Participants may enter the Contest by doing all of the following during the Contest Period:

- a. Visiting and filling out the form with required details

Each Eligible Participant can submit one entry during the Contest Period. Additional entries will not increase the participant’s chances of winning. Envu shall have the right

to disqualify any Eligible Participant if Envu, in its sole discretion, considers the participant to have or have attempted to have violated the Rules or otherwise acted in a disruptive or abusive manner. Entries that are incomplete, irregular, inaccurate, misdirected, falsified, altered, tampered with, lost or delayed shall be void. Any violation or attempted violation of any applicable laws, regulations, guidelines and/or industry standards shall result in immediate disqualification from the Contest.

The Eligible Participant shall ensure that their participation in the Contest is conducted in an ethical and professional manner and that all such participation is carried out in accordance with all applicable laws, regulations, guidelines, industry standards and community standards.

4. Prizes

Subject to these Rules, the prize is one (1) BBW Grill valued at \$600 Canadian dollars (the "**Prize**") and the Prize will be awarded to one (1) Eligible Participant as it relates to the Contest.

The Prize must be accepted as awarded and cannot be substituted, sold, transferred or assigned. Notwithstanding the preceding sentence, Envu reserves the sole and unfettered right, without any liability, to allow for a transfer of a prize from a Winner (as defined below).

Arrangements will be made with the winner for delivery of the prize at Envu's expense. The location specified by the Winner in writing provided that such location must be within Canada.

5. Winner Selection

A random draw to select a winner from the total number of Eligible Participant Entries duly received by Envu following the Contest Period will be made.

(the winner(s) shall hereinafter be referred to as the "**Selected Entrant**").

The Selected Entrant(s) shall be notified by in person, or by telephone and must respond to the contact person and number identified in the notification within thirty (30) minutes. If a Selected Entrant does not respond to the notification and otherwise comply with all other Rules, the Selected Entrant will not be declared a winner nor receive a prize and Envu shall draw for another Selected Entrant. If after three (3) such attempts an alternative Selected Entrant is not found, Envu reserves the right to donate the prize to a registered charity of its choice or to not award the prize.

6. Winners' Agreements

Before a Selected Entrant can be declared a winner and receive the Prize (the "**Winner**"), a Selected Entrant must:

- a. sign an agreement and release (the "**Agreement**") with Envu:
 - i. confirming the Selected Entrant's compliance with and acceptance of the Rules;

- ii. releasing Envu, its parent, affiliated and associated corporations, directors, officers, employees and agents and indemnifying them from and against any and all liability, causes of action, claims, loss, harm, damages, costs or expenses to the Selected Entrant and any other individual or entity arising out of, or directly or indirectly in relation to, the Selected Entrant's participation in the Contest, any violations of applicable laws, regulations, guidelines and/or industry standards and/or community standards, or receipt or use of the Prize, including without limitation, any use of misuse of or inability to use the Prize, any costs and expenses associated with the Prize, any losses or damages related to personal injuries, death or loss of destruction of property associated with the Prize, any rights of publicity or privacy and any defamation or portrayal in a false light;
- iii. granting and consenting, without any further compensation, to the use by Envu and its agents of the Selected Entrant's name, likeness, photograph (including the photograph provided as part of the Entry), place of residence, voice and expressions for administration and advertising and promotional purposes anywhere in the world and in any medium, including but not limited to the internet and social media platforms, as and in relation to being the Contest Winner; and

b. correctly answer, without mechanical aid or assistance, a mathematical skill-testing question to be administered by mail and/or telephone by a Envu representative.

The Selected Entrant must sign and return the Agreement within ten (10) business days of the notification date in section 6 of these Rules. Envu will contact the Winner respecting the details of receiving the Prize. If the Selected Entrant does not sign and return the Agreement as stipulated in these Rules, that Prize will be irrevocably forfeited and the Selected Entrant disqualified from the Contest.

7. Privacy and Submitted Materials

Any personal information received shall be treated by Envu in accordance with applicable privacy legislation and Envu privacy policies. Entry of a participant in the Contest constitutes the consent of such participant to the collection, use and disclosure by Envu of any personal information provided by such participant for the purposes of:

- a. administering this Contest and as identified in section 7 of these Rules (which consent cannot be revoked without disqualification from the Contest); and
- b. identifying and better understanding a participant's needs and preferences in order to develop and offer that participant information, products and/or services by Envu or its agents (which consent can be revoked by the participant separately contacting Envu and advising it of such revocation).

By participating in the Contest, participants expressly consent to Envu and its agents communicating with the participants by electronic messages sent in accordance with applicable legislation for commercial activities associated with this Contest or referenced in these Rules.

By participating in the Contest, each participant grants Envu an irrevocable, perpetual, transferable, worldwide, fee and royalty free license to copy, use, publish, transmit and create derivative materials using and from, any materials submitted by participant

in association with the Contest for any uses contemplated by the Rules including associated promotional and marketing purposes.

8. Limit of Liability

A participant, by submitting any Entry for this Contest (whether such participant is an Eligible Participant or is disqualified) agrees to and does release (to the extent permitted by law) Envu and its directors, officers, employees and agents from and against any and all liability for any loss, harm, damages, costs or expenses to such participant or any other individual or entity arising out of: incorrect or inaccurate transcription of entry information; incomplete, irregular, inaccurate, misdirected, falsified, altered, tampered with, lost or delayed entries, or entries received through impermissible or illegitimate channels (all of which will be disqualified); technical failures of any kind, including but not limited to the malfunctioning of any telephone, computer, network, platform (social media or otherwise), hardware or software; unauthorized human intervention in any part of the entry process or the Contest; electronic or human error which may occur in the administration of the Contest or the processing of entries; any processes utilized and/or decisions made by Envu regarding the selection and/or determination of the Selected Entrant and the Winner; and any decisions made by Envu in administering this Contest in accordance with these Rules, including without limitation, respecting disqualifications and eligibility determinations, prize substitution, prize transferability, changes to the Contest Period and any other changes to the Contest permitted by these Rules.

9. Disputes

A participant, by submitting any entry for this Contest (whether such participant is an Eligible Participant or is disqualified) agrees that: any and all disputes, claims, and causes of action arising out of or connected with this Contest shall be resolved individually, without resort to any form of class action; any and all claims, judgments and awards shall be limited to direct out-of-pocket costs incurred, including costs associated with entering this Contest but in no event lawyers' fees; and all rights to claim punitive, incidental and consequential damages, multiple damages and any other damages, other than direct out-of-pocket expenses, are hereby irrevocably waived. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO ALL SUCH PARTICIPANTS.**

A participant, by submitting any Entry for this Contest (whether such participant is an Eligible Participant or is disqualified) agrees that all issues and questions concerning the construction, validity, interpretation and enforceability of these Rules, or any rights and obligations in connection with the Contest, shall be governed by the applicable federal laws of Canada and the laws of the province of Alberta without regard to any conflict of law rules and to attorn to the exclusive jurisdiction of the courts of Alberta.
