SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures

General advice Move out of dangerous area. Place and transport victim in stable

position (lying sideways). Remove contaminated clothing immediately

and dispose of safely.

Inhalation Move to fresh air. Keep patient warm and at rest. Call a physician or

poison control center immediately.

Skin contact Immediately wash with plenty of soap and water for at least 15

Systemic treatment: Initial treatment: symptomatic. Monitor: respiratory and cardiac functions. In case of ingestion gastric lavage should be considered in cases of significant ingestions only within the first 2 hours. However, the application of activated charcoal and sodium sulphate is always advisable. Keep respiratory tract clear. Oxygen or artificial respiration if needed. In case of convulsions, a benzodiazepine (e.g. diazepam) should be given according to standard regimens. If not effective, phenobarbital may be used. Contraindication: atropine. Contraindication: derivatives of adrenaline.

There is no specific antidote. Recovery is spontaneous and without

sequelae.
