Terms and Conditions

- 1. In the General Terms and Conditions, the following definitions apply:
- a. Provider: Bayer Cropscience SA/NV, J. Mommaertslaan 14, DIEGEM
- b. Participant: the natural person who participates in the survey;
- c. General Terms and Conditions: these general terms and conditions;
- d. Action: 'Electric weeding city vehicle potential in Europe' survey
- 2. The Action is organized by the Provider. The General Terms and Conditions apply to the Action. By participating in the Action, the Participant accepts the applicability of the General Terms and Conditions and the Participant declares that he agrees with the content of the General Terms and Conditions.
- 3. These General Terms and Conditions may be amended at any time by the Provider. The Provider will post the amended General Terms and Conditions on the website https://www.environmentalscience.bayer.nl stating the date of amendment, or otherwise communicate that the General Terms and Conditions have been changed.

Attendees

- 5. Participants in the Promotion must be at least 18 years of age or older. Participants should be actively involved in control of vegetation in public areas. Suppliers are excluded

The Provider reserves the right to exclude a Participant from participation if the Participant acts in any way in violation of these General Terms and Conditions, or provides incomplete, incorrect or misleading data or information that is contrary to the law, or on otherwise acts unlawfully towards the Provider or third parties.

Prerequisites

- 10. In order to participate in the "Action", the Participant must register via the survey and complete the registration survey.

Personal data
