

2024 Range & Pasture Retailer Incentive Program

Details

+ The 2024 Range & Pasture Retailer Incentive Program is for qualifying retailers, recognized as leaders in the industry, who support efforts of enhanced land stewardship, safety and high-quality customer service. Maximize your retailer incentive by completing two simple steps to earn your Stewardship Bonus.

Qualifying retailers

- + Distributor retailers who have signed a current-year, applicable Envu Distributor Agreement or renewal letter.
- Independent retailers must purchase Envu products directly from a contracted Envu distributor.
- + Retailer must achieve minimum purchases at the HQ level for independent retailers or at the division level for distributor-owned retailers according to the following:
 - Minimum of \$10,000 in purchases of qualifying products to qualify for incentives.
 - The retailer must meet the requirements and is subject to program conditions.

How to participate

Maximize your retailer offer through two simple steps:

- + Complete a 2024 marketing strategy plan with your area sales manager (ASM) at the division level for distributor-owned retailers and the HQ level for independent retailers.
- + Complete the Envu Range & Pasture year-end retailer survey by location.

Incentive details

- + Incentives under this program are paid based on EDI information from contracted distributors and the completion of the retailer survey if submitted. The retailer survey must be submitted by October 15, 2024.
- + The Envu Range & Pasture year-end retailer survey replaces the previous requirement to submit grower sales data (GSD) via spreadsheet or Data Dimensions. You do not need a Data Dimensions account to complete the survey. It can be completed online at <u>us.envu.com/vegetation-management/range-and-pasture/survey</u>. The survey must be completed and submitted by October 15, 2024.

+ The retailer survey incentive will be paid if the survey is completed by each retail location selling participating products (listed below). Envu reserves the right, using auditors from Envu or an independent auditing firm, to verify all claims for payments under this program and, in matters of discrepancy, reserves the right of final decision.

- + Program period is from October 1, 2023, to September 30, 2024.
- + Program incentive will be paid by December 31, 2024.

Stewardship responsibilities

- + Stewardship is a critical part of the use of Invora® herbicide. We expect qualifying retailers to support applications made by commercial applicators and/or end users as defined below.
 - Provide sound recommendations on stewardship, including application timing and rates.
 - Support the end-user claim process by being the first point of contact and providing the required documentation to Envu.
 - Nonperformance claims agreed to by Envu will reduce the Stewardship Bonus by the amount of the claim but
 are limited to the total Stewardship Bonus earned by the retailer for the specific customer associated with the
 nonperformance claim. Research indicates that with proper stewardship and timing recommendations, the
 claims will be less than 1%.
 - There is no change in the current process to pay claims.
