

RangeView[™] Long Haul Guarantee

Envu is offering the RangeView™ Long Haul Guarantee program to qualifying ranchers who want to restore their lands impacted by certain invasive brush species.

The RangeView Long Haul Guarantee incorporates the use of the RangeView digital platform and Invora® herbicide along with rancher best management practices to achieve less than 5% canopy cover of honey mesquite (*Prosopis glandulosa*) and 10% canopy cover of huisache (*Vachellia farnesiana*, also known as *Acacia farnesiana*). The performance guarantee is for five years on areas treated with Invora herbicide. The guarantee includes treatment of existing honey mesquite or huisache per label instructions. The guarantee excludes targeted species seedling recruitment. It also excludes mechanically manipulated or chemically treated targeted species within the past three years as well as honey mesquite or huisache that is not deemed suitable for application due to weather or tree conditions.

As part of the RangeView Long Haul Guarantee, monitoring and evaluation of treatment performance may occur by the RangeView digital platform and/or visual inspection. If the canopy cover for the area treated is above the program guarantee beginning one year after application, Envu will reimburse 100% of the Invora herbicide product, application and adjuvant costs for the area requiring retreatment. The applicator must be preapproved by an Envu representative. Pastures can only be retreated once during the five-year period.

To participate in the program:

- All treatment areas must be enrolled in the RangeView digital platform.
- * An analysis of brush and tree infestation will be conducted to produce a map to guide the rancher's field validation and treatment decision on their land.
- The rancher determines which areas to treat and communicates that with a qualifying applicator.
- Invora herbicide must be applied at 24 ounces per acre or higher for mesquite and 36 ounces per acre or higher for huisache to qualify for the canopy cover guarantee.
- + After the application is complete, the as-applied file and Invora herbicide invoice must be uploaded in the RangeView digital platform where Envu will validate submitted information.



Terms, Conditions and Application Requirements of the RangeView™ Long Haul Guarantee Program:

Read and follow all Invora® herbicide label and stewardship guide instructions/recommendations for use.

Customer must follow the program recommended by Envu.

- + Application timing and rate:
 - For honey mesquite, apply Invora® herbicide at a minimum of 24 ounces per acre with methylated seed oil + an organosilicone (MSO-OS) spray adjuvant in late spring to midsummer when foliage is mature with a dark-green color.
 - For huisache, apply Invora herbicide at a minimum of 36 ounces per acre with an MSO-OS spray adjuvant in the fall before November 1.
- Apply aerially at a minimum of 4 GPA carrier volume or by ground at a minimum of 10 GPA.
- + Apply when the soil temperature reaches 75 degrees F at a depth of 12 inches.
- + Avoid applications if the leaf canopy is over 25% damaged due to hail, insects, disease or drought.
- * Avoid applications when new brush growth is present due to recent rainfall.
- + The above prescription may be adjusted, with prior written agreement from Envu, to accommodate specific site conditions or other factors.

Envu products must be purchased from an Envu distributor or retailer and applied by a licensed applicator.

The RangeView™ Long Haul Guarantee program only covers honey mesquite and huisache.

The applicator must complete full coverage of the target area for control of mesquite and huisache, following all requirements as stated on the Invora herbicide label and in the stewardship guide instructions/recommendations. The applicator is responsible for any retreatments as a result of skips, uneven applications, and deviations from Invora herbicide label wording and application instructions.

To determine if retreatment is necessary, a field inspection shall be made by Envu and the rancher to determine the level of control, and the final determination of performance will be at the sole discretion of Envu. Methods for determining control will include, but is not limited to, visual, remote sensing, asapplied map files and other sampling methods. Sampling techniques, sample number and sample size will be determined based on treatment area and other factors necessary to best determine the reason for poor performance.

Poor performance, plant injury, other property damage and other unintended consequences may result because of factors beyond the control of Envu. Those factors include, but are not limited to, weather conditions and any tank-mix partner effects or the manner of use or application. All such risks shall be assumed by the user or buyer.

Should retreatment be necessary, retreatment must be performed by an Envu approved applicator. Once approved by Envu in writing, the retreatment must be verified by providing a copy of the applicator invoice and spray application records to Envu. The retreatment rebate will be provided directly to the rancher (or contract applicator as determined by the release).

Acceptance of a retreatment rebate payment, in addition to a signed release and settlement agreement explaining the desire to fully and finally resolve and settle all claims that were asserted or could have been asserted in regard to this complaint, shall be considered fulfillment of the obligations of this RangeView Long Haul Guarantee. There is no further guarantee offered on retreatment.
