

RangeView[™] Long Haul Guarantee

Envu is offering the RangeView™ Long Haul Guarantee program to qualifying ranchers who want to restore their lands that have been impacted by certain invasive grasses. The RangeView Long Haul Guarantee program incorporates the use of the RangeView digital platform and Rejuvra® herbicide with rancher best management practices to achieve 80% or greater control of downy brome/cheatgrass (Bromus tectorum) and ventenata (Ventenata dubia) for up to four years after application for the areas treated with Rejuvra herbicide.

As part of the RangeView Long Haul Guarantee program, monitoring and evaluation of treatment performance may occur by the RangeView digital platform. If performance is a concern and less than 80% control is achieved, Envu will reimburse 100% of the Rejuvra herbicide product cost on retreatment acres if needed after two germination cycles or 24 months after application and up to four germination cycles or 48 months after application.

To participate in the program, all treatment areas must be enrolled into the RangeView digital platform where an analysis of ventenata and downy brome/cheatgrass infestation will be conducted to produce a map to guide the rancher's or land manager's field validation and treatment decision on their land. Ventenata is currently on several states' noxious weeds list, and treatments are made on a wider basis to address field-identified populations and prevent the spread to the remainder of the pasture. The rancher or land manager determines which areas to treat and communicates that with a qualifying applicator. Rejuvra herbicide must be applied at a 5 oz/acre rate or higher to qualify. After the application is complete, the as-applied file and Rejuvra herbicide invoice are uploaded in the RangeView digital platform where Envu will validate submitted information.

Evaluation of the 80% control standard will be determined by comparing the as-applied information for the treatment area to the same treatment area on the ground containing escapes of either downy brome/cheatgrass and ventenata. The portion of the treatment area where downy brome/cheatgrass and ventenata control falls below the 80% standard will be the portion of the treatment area that is eligible for retreatment. If retreatment is necessary, Envu will reimburse the cost of Rejuvra herbicide needed to retreat the area.



Terms, Conditions and Application Requirements of the RangeView™ Long Haul Guarantee Program:

Read and follow all Rejuvra® herbicide label and stewardship guide instructions/recommendations for use.

Customer must follow the Envu application recommendations:

- Application timing and rate: Apply Rejuvra herbicide at a minimum of 5 oz/acre in the June, July or August preemergence window.
 - Apply several weeks prior to weed seed germination and allow sufficient time to receive incorporating precipitation for herbicide activation.
- Appy aerially at minimum of 5 GPA carrier volume or by ground at minimum of 10 GPA.
- * Rancher agrees to manage grazing to ensure overgrazing does not occur, following the take-half, leave-half best management practice.
- * The above prescription may be adjusted, with prior written agreement from Envu, to accommodate specific site conditions or other factors.

Envu products must be purchased from an Envu distributor, retailer or county and applied by an Envu identified Top Flight Applicator.

The RangeView Long Haul Guarantee program only covers downy brome/cheatgrass and ventenata. The Top Flight Applicator must complete full coverage of the target area for control of downy brome/cheatgrass and ventenata, following all requirements as stated on the Rejuvra herbicide label and in the stewardship guide instructions/recommendations.

The Top Flight Applicator is responsible for any retreatments as a result of skips, uneven applications, and deviations from Rejuvra herbicide label wording and application instructions.

To determine if retreatment is necessary, a field inspection shall be made by Envu and the customer to determine level of control, and final determination of performance will be at the sole discretion of Envu. Methods for determining control will include, but are not limited to, visual, remote sensing, as-applied map files and other sampling methods. Sampling techniques, sample number and sample size will be determined based on treatment area and other factors necessary to best determine the reason for poor performance. Sampling may also include soil sample testing for presence of Rejuvra herbicide completed by third-party university or research labs.

Poor performance, plant injury, other property damage and other unintended consequences may result because of factors beyond the control of Envu. Those factors include, but are not limited to, weather conditions, any tank-mix partner effects, or the manner of use or application. All such risks shall be assumed by the user or buyer.

Should retreatment be necessary, retreatment must be performed by an Envu approved Top Flight Applicator. Once approved by Envu in writing, the retreatment must be verified by providing a copy of the applicator invoice and spray application records to Envu. The retreatment rebate portion for the Rejuvra herbicide used will be provided directly to the rancher (or contract applicator as determined by the release).

Acceptance of a retreatment rebate payment, in addition to a signed release and settlement agreement explaining the desire to fully and finally resolve and settle all claims that were asserted or could have been asserted in regard to this complaint, shall be considered fulfillment of the obligations of this RangeView Long Haul Guarantee program. There is no further guarantee offered on retreatment.

Envu reserves the right to modify or terminate this program at any time in its sole discretion.
